# Change in the Passenger Service Facilities Charge for International Flights at Tokyo International Airport (Haneda)

Japan Airport Terminal Co., Ltd. hereby announces that our consolidated subsidiary, Tokyo International Air Terminal Corporation, has released the change of the passenger service facilities charge for international flights at Tokyo international Airport (HANEDA), as shown in the attached sheet.

It is anticipated that the impact the change in the charge will have on our performance for the fiscal year ending March 31, 2022 will be negligible.



# **Revision of International PSFC at Haneda Airport**

Tokyo International Air Terminal Corporation (TIAT) applied to the Minister of Land, Infrastructure, Transport and Tourism for an increase in the Passenger Facility Service Charges (PSFC) at Tokyo International Airport (Haneda). Approval from the Minister has been received and we wish to announce the new charges.

PSFC(\*) is a charge for facilities used by international passengers in the passenger terminals and is levied upon international departure and transit passengers.

\* Those facilities include departure and arrival lobbies and concourses, and baggage handling facilities.

Since March 2020, TIAT in conjunction with Japan Airport Terminal Co., Ltd. and in consultation with the Ministry of Land, Infrastructure, Transport and Tourism has undertaken major facility development projects such as the expansion of the main and satellite buildings in Terminal 3 and expansion and modification of the common international areas in Terminal 2 in order to accommodate the function enhancement of Haneda Airport (a project to add another 39,000 international slots per year to capacity). In order to recoup that investment and provide for the increased operating costs, etc. resulting from the expansion of those facilities, revised PFSC charges as shown below will apply to passengers departing from those terminals who have been ticketed on or after 27 March 2022.

We will continue to make further efforts to improve the safety, convenience, and services of the passenger terminals in terms of both facilities and services, with the aim of providing facilities that customers can use with ease and comfort.



#### Details of PSFC Revisions

1. International Passenger Facility Service Charges (Incl. Consumption Tax)

\* However, the child charge will apply to children under 2 years of age traveling on a child's ticket.

### 2. Commencement Date

New charges will apply to passengers ticketed on or after 27 March 2022.

\* The present charge will continue to apply to passengers ticketed before that date.

\*As before, PSFC will be collected in conjunction with the airfare when passengers purchase their tickets. (On ticket collection)
